DAILY INTERNAL INFO SUMMARY 10-14

TWENTY-TWO MORE VC WERE KILLED BY SECOND BRIGADE ELEMENTS MONDAY AS TROOPS OF CHAPLEY COMPANY, 4/47 INFANTRY DISCOVERED A SUSPECTED VC REST AREA IN THE SOUTHEAST CORNER OF GO CONG PROVINCE.

IN AN OPERATION SUPPORTED BY ARMY AIR CUSHIONED VEHICLES (ACVS), THE TROOPS ACHIEVED CONTACT WITH THE VC ELEMENTS ABOUT 1612. THE GROUND FORCES KILLED 19 ENEMY. GUNDRIPS, WHICH MOVED INTO SUPPORT THE FIGHTING, ACCOUNTED FOR ANOTHER SEVEN. IN ADDITION, THE INFANTRY SEIZED FIVE WEAPONS AND DETAINED 23 VIETNAMESE FOR QUESTIONING.

ALL OF THE 4/47 TROOPS WERE WITHDRAWN FROM THE GO CONG-BINH DAI AREA EARLY MONDAY AFTERNOON BY BOATS OF RIVER DIVISION 92 FOR RETURN TO THE MRB.

MEANWHILE, ONE ADDITIONAL BODY WAS FOUND MONDAY IN A SWEEP THROUGH THE AREA OF SUNDAY NIGHT'S CONTACT BY BRAVO COMPANY, 3/47 INFANTRY 20 KILOMETERS EAST OF BEN TRE. A TOTAL OF 26 VC WERE KILLED IN THE BATTLE WITH AN ESTIMATED REINFORCED COMPANY.

IN OTHER ACTION, BOATS OF RIVER DIVISION 152 SUPPORTED 6/31 INFANTRY BATTALION AND A REGIONAL FORCE COMPANY IN A SEARCH AND SWEEP OPERATION IN WESTERN DINH TUONG PROVINCE, EIGHT KILOMETERS NORTHWEST OF VINH LONG. WHILE EN ROUTE TO THE BEACHES, THE BOATS RECEIVED SMALL ARMS AND AUTOMATIC WEAPONS FIRE WHICH WAS QUICKLY SUPPRESSED WITH 20MM CANNONS.

THE TWO TF 117 TASK GROUPS CONTINUED THEIR REALIGNMENT MONDAY AS APL-32 AND APL-26 EMBARKED RIVER DIVISIONS 91 AND 112, RESPECTIVELY, AND JOINED TASK GROUP ALPHA. RIVER SQUADRONS 13 AND 15 MOVED ABOARD THE MERCER AND NUZCES WHICH WILL BEGIN OPERATING WITH TASK GROUP BRAVO.

WITH RIVER DIVISIONS 91 AND 112 RETURNING TO THE LINE, RIVER DIVISION 92 MOVES TO THE BENEMAH AND ASSUMES RESPONSIBILITY FOR MRB ALFA DEFENSE AND RIVER DIVISION 111 GOES TO THE WESTCHESTER COUNTY TO BEGIN SUPPORTING 3/34 ARTILLERY.
