

Getting the benefits you need and deserve from the Veterans Administration!

I fought my own personal battles with the VA from 1977 to the late 1990's. Unfortunately, there were a lot of veterans from the two previous wars who ran the VA system. Many viewed our generation as undeserving because ours was not a real "war". I beg to differ as we all do. That began to change in the late 90's when they began passing away or retiring. It was then that the VA began paying more attention to us Vietnam era veterans.

In 1986 I got shafted by the VA. I had finally chosen to be free of alcohol in 1976. After a few years of struggling with recreational drugs, I quit them as well. In 1986 I had just married for the first time in my life. A month later the VA scheduled a re-evaluation for my PTSD. I met with a psychiatrist. Not too long into the exam he asked me, "When are you going to quit sponging off the government Mr. Harris?" If I had not been a young Christian I may have leaped over the desk and hurt him. This man had immigrated from Egypt. I gathered myself and said, "You came to my country to ask me this question? I don't need you!" and walked out of the exam. Later VA dropped me from 30% to 10% because I was married and perhaps due to the fact that I didn't attack the examiner. Years later I filed a claim against the VA claiming Clear & Unmistakable Error (CUE). The claim went back to the Board of Veterans Appeals (BVA) and I was awarded all of my back pay.

I am relaying this personal story to help you understand that the VA abuse caused me to fight not only for myself, but for my fellow veterans. At first, I functioned as what I call a "Rogue Advocate". I had a deep passion to go to battle with the VA system. For a few years I indirectly advocated for my veterans by preparing all of their paperwork and forms as a sort of ghost writer. As I learned the VA system, I began to win small skirmishes and then larger battles. It was so very gratifying to see my veterans receive the EARNED benefits due them. In 2006 I became an accredited Veteran Service Representative (VSR) with Vietnam Veterans of America (VVA). The position is different than a Veteran Service Officer (VSO) who is more highly trained. I concentrated on the VA claim process and continued winning more claims for my vets.



An advocate must learn how VA uses key wording. If VA does not see these statements, then a veteran can have his claim denied. One is: "It is as least likely as not that the veteran's disability was incurred in service." This sways the pendulum in favor of the veteran.

I would like to make some points from my personal experiences:

1) Do not use excuses like: "I don't deserve it" or "someone else deserves it more" or "It's not that important this late in life." VA must act to provide ALL veterans with the EARNED benefits that are due them. If you don't want to pursue a claim or claims for yourself, then do it for your spouse, your children or your grandchildren.

2) Utilize a VSR or VSO to assist you in the process. The best way to find a good one is to ask around the veteran community. They will know the "go to" person. If for some reason you do not feel that the individual is representing you properly then revoke their limited Power of Attorney and find a new advocate who cares about you and your claims.

3) Be careful when listening to what other veterans say is the truth. Rumors can prevail in the community. You need to hear it

from someone who is qualified to provide the correct answers.

4) If you do not agree with a VA decision then appeal it. You would not believe how many claims I won on appeal. Don't take "no" for an answer unless it is obvious.

5) Look out for your spouse in the process. He/she is your "dependent". Same with younger veterans with children. If you end up rated 100% disabled then he/she will most likely receive healthcare and monetary benefits before and after you pass.

6) It is never too late to file if you feel that your disability is related to service (service-connected). Also, if you are rated service-connected and your disability worsens, then you can re-open your claim for a higher benefit.

7) A veteran does not have to be rated a Schedular 100% to earn compensation and benefits. There is also a benefit titled Total Disability due to Individual Unemployability (TDIU). This is when a veteran's disability affects him/her to the point of not being able to secure "Substantial Gainful Employment".

8) VA continues to add to the "Presumptive" conditions for Agent Orange. If you suffer from any of them and served in-country Vietnam or at other duty stations where they sprayed the chemical then by all means file a claim. The VA is not real clear on what additional benefits are available once a veteran is service-connected. Especially when one is rated 100% Scheduler or by TDIU. Through the years I kept adding to a couple of files that I kept updated. They dealt with "100% Benefits" and "Widow and Widower Benefits". Neither is all inclusive, but they may provide you with some guidelines to follow. I would be willing to send the Word Files to anyone who would like to investigate them. Tips From Other MRFA Members

James Wollner. I have learned that the VA will give you almost everything BUT you must ask them. The best thing you can do is take advantage of Veteran organizations like the DAV, VFW, American Legion, etc. I myself went through the DAV and let them fight for me with the VA, I ended up with 100%.

Jerry Barney. My advice is to never give up. Be persistent and if you can't get a prompt answer don't hesitate to get ahold of a different Veteran Service Officer even if you have to use one in a different County. Bottom line, if you have filed for a disability & been waiting for a long time without getting an answer go to your local Federal Congressperson for help.

Ron Rutowski SGT US Army 2/60th Infantry 9th Infantry Division 67-68. I have one simple answer, as a category one Purple Heart, SC veteran. 1) Get a very good service officer at the DAV or at a veterans organization rather than the VA. The main purpose of the VA is to administer veteran benefits, not represent veterans. It's not that the VA doesn't care about veterans. It's just not their main responsibility. Interview your service officer and make sure they have years of experience representing Vietnam war veterans, and that their workload (is no too busy) to give you the time you deserve to make sure you get all the benefits you are entitled too. 2) Most VA disability benefits are denied due to insufficient/incomplete documentation presented to the VA.

Ask your service officer to provide you with a printed disability form (pertaining to the disability to are claiming) so that you can take it to your non-VA doctor to fill out. This form will help the VA to fast track your claim. The service officer can also give you the VA rating schedule relating to your disability claim. Review both forms with your service officer before they submit it. This review will let you know about what percentage of disability might be awarded. If different review that difference with your service officer. File an appeal if justified.

"Your healthcare at the VA is only as good as you advocate for it"

I also believe that Healthcare at the VA is excellent when you can get it.

Don't give up, and for Pete's sake be nice to the people who answer the phones, they are navigating a huge bureaucracy themselves.

Chris Sater asked me to pass along information on a resource, members of the MRFA may be interested in. Chris called on this organization a few years ago. A friend of Chris's has used the "VetAssist Program." They are located near the site of our 2023

Reunion, in St. Louis. If there is enough interest, we may be able to arrange for them to have a table at the Sheraton to answer questions for our members. From their website; "Veterans Home Care's exclusive "VetAssist Program" helps veterans, or their surviving spouses, apply for a little-known Department of Veterans Affairs benefit to pay for assistance with activities of daily living. Home care includes a personal care assistant and the latest medical alert system with Alexa® technology. We can get home care started before the VA processes the claim and before our clients receive VA funds.

We provide a 0%, interest-free loan so home care can begin almost immediately.

The loan can be reimbursed with funds from the Department of Veterans Affairs (VA) upon approval of the Aid and Attendance benefit. The VetAssist Program also furnishes continuing client service and on-going compliance monitoring, all with no out-of-pocket costs." https://veteranshomecare.com/

Have YOU had YOUR "Honor Flight?"

Dear Mobile Riverine Force Association Veterans and Veteran families,

Let me introduce myself! I'm Dina Bridge, wife and mother of two from Springfield, II. I am Terry Sater's daughter and I want to tell you about a once in a lifetime opportunity I experienced with my father this August.

I had a chance meeting three years ago with Honor Flight Coordinators in Springfield; Steve Wheeler and Joan Bartolon. They educated me on the process of nominating a veteran for Honor Flights to Washington D.C. They told me moving, personal stories of how inspiring and fulfilling it is to be able to take servicemembers to D.C., celebrate them, honor them, and watch them reminisce on their time spent serving their country.

I went home that very day, and filled out online forms to nominate my dad.

Of course, we all know what came next....The pandemic. Two years of grounded Honor Flights. Life moved on, and from time to time we'd bring it up to each other and think "someday..."

"Someday" came on August 30th! We could not have been more excited for the trip. We knew the itinerary was packed with war memorials, monuments and a museum, but there were a couple surprises in there that I, as his Guardian for the day, couldn't wait for him to experience!

I don't want to give away all the stops and surprises, because I want to encourage any Veteran friend or family member to nominate a Veteran TODAY, so they can experience it first-hand. I will say that I felt honored to be my dad's Guardian on this incredibly special and moving trip. I kept thinking how amusing it was to switch roles for the first time in my life and be responsible for my dad for the day. (Although to be honest he was not entirely comfortable



with abdicating protection and security to his daughter. I'm joking. Not really.)

We took our time at the Wall. It was a priority that day, to take as much time as we could to find the names of the people that have been a part of my dad's life long after they've been gone. I felt like I was visiting their grave, in a way. Some names on The Wall are as familiar to me as blood ancestors.

We were quiet. I was listening.

The Changing of the Guard in Arlington Cemetery was an amazing end to our time in D.C. A storm blew through. Standing in the rain and watching this sacred ceremony, I had goosebumps. It will never be forgotten.

Watching my dad interact with and share stories with other veterans was so great to see. He told me how much he enjoys meeting other veterans and hearing about their experiences. On this particular flight, we even had one World War II veteran and a couple Korean War veterans.

Back home, was the kind of full circle, life moment that I don't have the words for, even now, with a month to contemplate it!

It has always been a heartbreaking visual for me, ever since I was a little girl, to think of the way my dad and his brothers were treated upon return from the Vietnam War. Traumatized, weary, and homesick, only to be received with vitriol on homeland soil is something I can't ever wrap my brain around. The community came out to welcome our veterans home. My dad shook hands with hundreds of people he's never met. They looked at his name tag. They thanked him by name. Other Vietnam veterans simply said "Welcome home, Brother."

I would do it again in a heartbeat. If you have the opportunity to take a loved one on this trip, do it! If you are not able to do it, nominate your loved one, and a Guardian will be provided!

You can also volunteer for the Honor Flight program, if you have one in your area. There are many, many people who work together to make these trips happen.

I know in the future, I will be heading to the airport after the next flight, ready to shake hands with more Veterans coming home.

The crew of our chartered aircraft fought to be assigned to our crew and entertained, fed, and made each of us special vets.

Honor Flight is a total non-profit organization. By that I mean 99% of all funds raised are used for the mission of getting Veterans to DC to see their memorials. The number of trips each year and the number of Veterans that go on these trips is determined by the amount of funds that each Hub raises. All guardians and board members pay their own way. Honor Flight was initially set up to accommodate WWII Veterans. Those numbers have diminished and now it is open to Korean and Vietnam Vets.
