

One never knows what the future will bring but the most important thing is to get an education no matter where, a trade or college or an apprenticeship!

As I said earlier I would do the same thing I did then and that is to get an education in something.

Frank Jones, RivDiv 152, T-48 Boat Captain. 07/69-07/70 Enjoy the rest of your life because I made it home.

Donald Saylor, Radioman/gunner on M-92-1. We were the first of the boats... Division 91 and Div 92, 1967. I think the biggest thing I would pound into my head is that drugs and alcohol have never been anyone's friend. They certainly weren't mine. Sure, they might let you escape for a couple hours, but at what cost. They destroyed fourteen years of my life.

There is a God out there and while He will never push himself on you, He anxiously waits for you to call on Him. He has the answers and if you choose to listen, they WILL work. My younger years could have been much different had I made the right choices.

"What advice would you give your younger self, just coming home from Vietnam and facing the rest of your life?"

Robert "Bob" Flaige, SSG USA (Ret.). Echo Co. 3rd/60th, May 67-May 68. Return to college and finish my education. I enlisted in the army in my junior year. After spending almost three years in service, I knew I had unfinished business. Appreciate the opportunity to do so and don't let little things bother you and just enjoy life as it comes.

Patrick Hartley, USS Mercer APB-39 April 1968 to June 1969. I would have recommended finding other Vietnam vets closer to where I lived. Even now, my best friends are other vets.

A.J. McCaskey, 4/47 Co. A, 9th Infantry Div., 1968-69. I was wishing/hoping to immerse myself back into the real world and to get on with my life as I once knew it. I wasn't ready for a real job, so I enrolled into college, thanks to the G.I. bill. It was the best thing I ever did. Once I consulted with my class advisor who sensed some confusion on my part, she looked me in the eye and reminded me I had my whole life in front of me. Make an effort to do something good with it. So, locating and consulting with some sort of post war support that works for you, be it family, professional help, whatever, will help remind you that life goes on, that you can do it!

Tom Rattan, October 1969 TO 70, RivDiv 111, 131, 153 Don't hide your service and what you did. Most people did not know that I was even in Vietnam for many years.

Nick Miller, Chief Staff Officer, RivDiv152. Jul 68-June 69. The War was an interlude. Don't let it distort your perception of reality in the normal world. Hold on to the lesson that you can reduce your level of risk and still stay on mission. But The War is not who you are.

Vincent Dellipaoli, 9th Infantry, 3/47, 68-69,11BRAVO. We were attached

to the MRF. When I came home from Vietnam, March, 1969. Even though I still had seven months left in the Army, I locked Vietnam in the back of my mind and threw the key away. For the next fifty years, I struggled with suicidal thoughts. My mood swings were drastic, to the point that I was taking it out on my family. When I got into those moods, my wife would tell my kids to leave daddy alone, he doesn't feel good. Years later, after I got the help, my wife told me that the family had to walk on eggshells for fear of me possibly harming them.

It wasn't until 2019 that I finally went to the VA. It wasn't until I got help that I realized how bad my PTSD was. I now go for counseling at the local Vet center. I go once a week, and I see the VA shrink every two months. My answer to your survey question is; don't wait get the help. I talk to Iraq and Afghanistan vets and that's what I tell them. Get help right away. You can't do it on your own. Getting the help saved my life and my family.

Pat Kelly, RM2 C-151-1 Everything worked out fine. Have been very fortunate. Only regret is that I spent my saved money from Vietnam on a car instead of buying real estate in my home of record, Pigeon Forge, Tennessee.

Herschel Hughes, Colleton OPS '68-'69. By the way, the quilts of Valor folks are the greatest. I was presented with my quilt with a former Colleton crewman, Lee Whitehurst. He was a plank owner and brought the Colleton over from the states before being transferred to PBR's. There was a total of nine of us all Vietnam era vets. Kudos to the leadership for setting that up for us. The ceremony touched me deeply; a lot loose ends and hurts that had been bouncing around in my head for decades just seemed to melt away when they draped that quilt over

me and the nice lady gave me a hug. As for your question: what would I tell my younger self following the return? Don't lose heart; stay proud; don't buy into the melancholy of the age; keep faith in your country; keep faith in your God; keep faith in yourself; there are huge mysteries in life; you'll never get it all figured out; when you lead sailors and marines in the rest of your career, lead them to survive and to win; give them hope and purpose; always know where the nearest Chaplain is; and don't abandon your church just because they don't get what service in Vietnam was like.

Randy Peat, "No one is shooting at you anymore. You are 10 foot tall and bulletproof. You can't do anything so let's get moving"

Ken Kalish. RivPatSec 523, Vinh Long, then GMG2, '67, '68 '69. Retired as a JOC. Take your time. Consider each decision and wonder what the proposer wants from you. Don't try to go back to what was before you left because it isn't there. Build yourself a life but take time to learn what is new since you left. Use your resources wisely. Learn how to accept beauty and quiet.

Douglass C. Ogden, Lieutenant, US Navy (1963-1971), USS AULT (DD-698)-JULY1967-AUGUST, 1969, INSHORE UNDERSEA WARFARE GROUP ONE, UNIT THREE OUI NHON, RVN, NOVEMBER, 1969-JUNE 1971. My answer is probably too long, but the only way I can answer is to ramble a bit.

I graduated from the US Naval Academy on June 7, 1967 and went right to Viet Nam on a Destroyer on the gunline. I went back in November 1969 and spent a year and a half in-country, first with Inshore Undersea Warfare Group One, Unit 3 in Oui Nhon, then as Senior Advisor to that team when we turned over to the Vietnamese Navy. At that point, I decided to leave the Navy and try something else, so I went to Law School and graduated in 1974. I hated Law School but I knew it wouldn't hurt me, so I finished, but while I was there, I heard some women in the Class behind me talking about women then being able to join the FBI. I immediately went over to

the local Bureau office, applied, and was accepted in May 1975.

I spent almost 24 years as an FBI Agent working Violent Crimes, Drugs and Terrorism and loved every minute of it. I retired in 1998, but the best thing was that my 8 years in the Navy counted towards my retirement.

The connection I want to make with your question is what happened to me when I returned from Viet Nam and landed in San Diego in 1971. As I walked through the terminal, I was spit on and called a baby killer. Today, when I wear a Viet Nam Veteran baseball cap or a Viet Nam T-shirt, I get stopped all the time and thanked for my service. Bottom line-do the best job you can do in the Service-take advantage of every opportunity to advance and improve yourself in whatever you decide to do, and learn from your experiences. There are the names of 9 of my Naval Academy Classmates on the Viet Nam Wall, none of whom I will ever forget. I hope this makes sense-thank you.

Joe Rosner, RivRon 15, M-6. 07/69-06/70. Get professional help sooner!

Wendell Affield, Tango 112-11, Feb-Aug 18, 1968. Author: *Muddy Jungle Rivers and Chicken house Chronicles*. Fifty-five years after I enlisted at 17 years old, here is my advice to my younger self. Don't jump into a serious relationship. You really know nothing about women. You have lived in a controlled environment during your military service and have not matured/grown socially.

March 22,2025, my second wife Patti and I will celebrate our 50th anniversary!

Bob Schrader, D Company 9th Med Bn 9th Infantry Division. "Go with the flow. It's amazing how life changes as quickly as combat. I was planning on a military career or medical school, but was talked into rejoining the family business. That changed as well - too much family. More career changes including commercial pilot, Deputy Sheriff, and going to law school, practicing law in a firm and then solo and becoming a judge. I retired and taught school to keep active. Now I write novels.

I often wondered how a military career would have been. A general or a dead Huey medivac pilot.

I went with the flow and obtained benefits that would not exist if I stayed my original course. I have two wonderful daughters, at least one I would never have met (adopted), became a legal beagle and experienced much of a pretty good life. Glad I took the ride along a different road

Al Breininger, CSO, RivDiv 91, Oct 1966 - Dec 1967, NIOTC Riverine Instructor, Feb 1968 - Oct 1969. Nothing different from what I did. I came home, spent another 20 months in the Navy training people going to the brown water units in Vietnam, giving them the best that I could for operating in the Delta. Got out of the Navy and started working in a manufacturing plant for one of the Johnson and Johnson divisions. My focus was getting on with life, and it stayed that way for 27 years. After attending my first MRFA reunion in 1997, my time in Vietnam came more to the forefront. I had more pride in my service because I had people who could understand the job we did.

I spoke very little about my Vietnam experience between 1970 and 1997. Nobody was interested in hearing about it, so I did not devote any time to it,. Working and raising my kids became a priority.

Reading Rick Atkinson's "The Long Gray Line", which featured several of the Army officers who were with the 2nd Brigade of the 9th Infantry Division and the MRFA, got me into reading a whole lot more about not only our experience in the Delta, but about the whole Vietnam story. And today I am much more vocal about both my experiences. The experience had a major impact on my life going forward from 1967. I learned a lot about myself, and there are no regrets, or things I would change.

I was called, served, survived, learned, and am better for having done so.

Clarence Eugene Sasser







Member Clarence Eugene Sasser passed away on May 13, 2024. While in Vietnam he served with Headquarters Company, 3rd Battalion, 60th Infantry Regiment, 9th Infantry Division from September 1967 to January 1968. Specialist First Class Sasser was awarded the Medal of Honor for Conspicuous Gallantry and Intrepidity for his heroic actions as a Medical Aidman on January 10, 1968. Clarence was preceded in death by his spouse Ethel L. Sasser.

CITATION:

The President of the United States of America, in the name of Congress, takes pleasure in presenting the Medal of Honor to Specialist Fifth **Class Clarence Eugene Sasser** (ASN: US-54511001), United States Army, for conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as a Medical Aidman with Headquarters & Headquarters Company, 3d Battalion, 60th Infantry Regiment, 9th Infantry Division, in action against enemy aggressor forces during a reconnaissance in force operation in Ding Tuong Province, Republic of Vietnam, on 10 January 1968. Specialist Fifth Class Sasser's company was making an air assault when suddenly it was taken under heavy small arms, recoilless rifle. machinegun and rocket fire from well-fortified enemy positions on three sides of the landing zone. During the first few minutes, over 30 casualties were sustained. Without hesitation. Specialist Fifth Class Sasser ran across an open rice paddy through a hail of fire to assist the wounded. After helping one man to safety, he was painfully wounded in the left shoulder by fragments of an exploding rocket. Refusing medical attention,

he ran through a barrage of rocket and automatic weapons fire to aid casualties of the initial attack and, after giving them urgently needed treatment, continued to search for other wounded. Despite two additional wounds immobilizing his legs, he dragged himself through the mud toward another soldier 100 meters away. Although in agonizing pain and faint from loss of blood, Specialist Fifth Class Sasser reached the man, treated him. and proceeded on to encourage another group of soldiers to crawl 200 meters to relative safety. There he attended their wounds for five hours until they were evacuated. Specialist Fifth Class Sasser's extraordinary heroism is in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Armv.

Member William Andrew "Andy" Curtner passed away on August 6, 2024. While in





"First I studied the maps. Then a U.S. Army plane carried me high and low over all the likely places, when muddy beaches and mangrove swamps meet the South China Sea. I did my best, But I could find only eight dragons.

Yet how could that be, when the Vietnamese call the Mekong River the Cuu Long Giang ---the River of the Nine Dragons?

In Vietnamese imagery, a waterway is a benign, life-giving force, a dragon; and as the great river, nearing its end, splits to form the many-mouthed Mekong Delta, the number of dragons correspondingly multiplies. To as many as

eight, as far as I could see.

Dragons Watered by Monsson Rains

I consulted my friend Ton That Thien, long a mentor on matters Vietnamese. Now he was Minister of Information in Saigon.

He smiled. 'There really are only eight," he said. "But eight is not a lucky number. It has to be seven or nine. So, we had to find another one, and we did. But it is very small, very narrow, and less than ten miles long. I hope you are not too unhappy to have missed it."

....."War, on any battlefield, is a nightmare. The Mekong Delta compounds the horror. To fight here means tortuous slogging through snake-ridden swamps, where sucking mud grips the legs like wet concrete. The enemy may be only five feet away, yet unseen in the thick jungle"

...."First, the war. I saw it blazing most fiercely in South Vietnam, where the U.S. Navy's "miniature battleships," painted green and built expressly for combat along the Mekong Delta waterways, pitted their rapid-fire cannon against Viet Cong rockets made in the Soviet Union and in China."

Those deadly rockets spewed from bunkers hidden in dense greenery, sometimes along canals so narrow that the boats could not turn around. "It's like the old days," said the commodore of the River Assault Flotilla, "exchanging broadsides at 15 to 20 yards, pointblank

.....I went on a mission with the unique Mekong Delta Mobile Riverine Force. The troops came from the U.S. Army's 9th Infantry Division. The U.S. Navy contributed River Assault Flotilla One, specialized armored craft up to 60 feet long: troop carriers, boats with tiny landing pads for helicopters, flame-throwing boats, monitors carrying mortars and turrets with cannon. But for all their armor, ever vulnerable to VC rockets.

The Riverine Force normally sought out so-called VC main-force units along the canals. But now there would be a sweep of an island in the Song Tien Giang branch of the Mekong. I heard the briefing on the flagship.

Thoi Son Island, five miles long, one-mile wide, eastern tip just south of My Tho. Known VC liaison route. From here the 516th VC Battalion could mortar My Tho. One of its platoons might be on the island, probably also elements of the 332nd Sapper Company, to set booby traps and snipe at shipping. Our artillery stood ready near My Tho, air strikes were on call.

Our assault boats would surround the island before dawn. A plane would play a tape, telling the people not to run-whoever ran would be considered VC. "We want to walk up to them and question them."
