


COMMENTS ON THE USS MIDWAY PREMIERE OF "THE MOBILE RIVERINE FORCE."

"After our tragic reception home from Vietnam in the 60's, finally, the veterans of the Army & Navy that endured that war get the recognition, legacy, and the homecoming that we had been missing."

David Todd, Medic, B Company, 3/47th, 9th Infantry Division, Jan 1967 to Nov 67.

"I spent January, 1967 to April 1968 on the USS Colleton APB-36, one of the original barracks ships assigned to the Mobile Riverine Base of Task Force 117. I was fortunate that our ship was never attacked and the closest I got to combat was carrying stretchers from the medevac helicopters down to the surgery suites and standing watch on the flight deck over the dead in their body bags.

I knew that both the Army units and Navy boats took heavy casualties just about every time that they went out. I knew that the Army guys spent those three-day missions tromping around rice patties and suffering foot problems as a result (when they were on the ship they always wore flipflops to dry out). What I did not know was the horrors of battle that they faced. This film fills in that gap for me. It consists of two hours of interviews of the soldiers and sailors describing losing their friends, wondering if they were going to die that day and the misery of insects, snakes and trying to find dry places to sleep. The acts of true heroism that were shared in the film were very humbling to me. As I have said in other posts, I feel like I am stealing their valor when I wear my River Assault Force TF 116 cap. However, I have always been very

"I cannot say how much this movie means to me and my family. My widowed daughter-in-law, Michele, and my two grown grandsons, Connor and Riley, who live in Escondido, Ca. joined my wife, Anne and I who flew out from Orlando, FL. for the premiere on the USS Midway. First, the venue was suburb. I have taken my son, Matt, and my grandsons to the Midway on numerous outings over the years the grandsons were growing up. We even met an original Midway crew member while touring the engineering spaces years ago. A 1966 classmate from the USNA, Harry Thaete, is a docent aboard the Midway.

But let me say something about the film It honored all the folks it needed to honor. All those boat crews: all those soldiers. As a young line officer and the Operations Officer for the USS Colleton (APB-36) from June '68-June '69 (and GO OOD/Conning Officer for General Quarters transits) I was humbled to get pieces of the history that I had not heard before much less seen personally. After the premier, my family and I returned to my daughter-in-law's home in Escondido buzzing about the film. I did my best to fill in the personal side of things from my experiences and perspectives as a Colleton officer.

The next day I used the MRFA website to connect with the Naval Historical Command and downloaded all the ship's logs from my arrival to the Colleton to her return to CONUS in late '69 after I had rotated home. I have spent hours poring over them trying to connect the dots between the log entries and some of the events described in the movie with which I was not personally involved. I will continue this process to try to understand the scope of the movie and the breadth of the events covered. I have also promised myself to write my own story of being a ship's officer on the Colleton and the experience of piloting the ship up and down the Mekong as well as navigating for repair trips to Sasebo and Subic in the fall of '68. I am growing painfully aware for the first time that the USS Westchester County may have been our replacement ship while we were in that much-needed repair voyage to Japan/Subic. I hope to determine, if in fact, those mines would have been meant for our ship had we not been absent for repairs.

All in all, the more the facts come out, the more blessed I feel to have played the support role that I did for such an amazing group of sailors and soldiers. It is truly a brotherhood. God bless the MRFA. I am sure that my Vietnam experience preceded by destroyer ops in TF 77, and subsequent service in TF117, contributed to my aspiring to be and then becoming a Navy Clinical Psychologist. I have spent a major portion of my life trying my best to serve military personnel and veterans. There is no one on "God's green earth" more deserving of all the praise I can muster."

I served with B Co., 3/60th, '68-'69. Our company was on the Westchester the night it was mined. The navy lost 18 men, 2 ARVNs died, and Bravo Co. had 5 infantrymen who drowned in diesel fuel in the bottom berthing compartment on our side of the ship. Bravo members have managed to go back through our guy's old records, and formed a list of over 100 men who served in B company during the three years we were in the delta. We have had reunions every two years since the 1990's, and just had one last October, in San Antonio. There were 45 of us vets, and around 100 friends and family. One of our Bravo brothers, Ed Eaton, wrote a book, 'Mekong Mud Dogs' which you may be familiar with. Ed attends all of our reunions and was at our last one. I saw your post on Facebook about the showing of the documentary, and would really like to

see it. hopefully the dates and times that it will be on tv will be posted so that we can all view it. Also, I have read a lot of the books that you have suggested for reading, and appreciate your reviews about them. please keep us informed. stay healthy my MRF brothers.

General Hal Moore on Leadership in War and Peace

Thoughts on Battlefield Leadership

Three strikes and you are not out. There is always one more thing you can do to influence any situation in your favor, and after that one more thing, and one more thing after that.



- In battle, the leader must look inward asking, "What am I doing that I should not be doing, and what am I not doing that I should be doing?"
- A leader must be visible on the battlefield and exhibit confidence under any set of circumstances. The determination to prevail must be felt by everyone in the organization.
- In battle, remember that when there is nothing wrong, there's nothing wrong *except there is nothing wrong!* That is when the leader must be ready for anything.
- Prepare your unit for your death and for the loss of your next in command, and so on through the organization. At every level the Soldier must know how to take over for the person he reports to.
- Always trust your instincts. Instincts and intuition give one an immediate estimate of a situation. Your instincts are the product of your training, reading, personality and experience. If my head tells me one thing and my gut tells me something else, I always go with my gut.
- Troops perform well in combat when they have received stressful, realistic training; rigorous physical conditioning, and stern, fair and square discipline. It is equally important to meet their personal needs including food,

water, mail and information about what is going on and why.

• Soldiers in battle do not fight for what some leader says on television or in a speech. Soldiers in battle fight and die for their buddies. They do not want to let their buddies down. It is a matter of honor. (From Special Issue "Armchair General," September, 2004. Harold Gregory Moore Jr. (February 13, 1922 – February 10, 2017) was a United States Army lieutenant general and author. He was awarded the Distinguished Service Cross, the U.S. Army's second-highest decoration for valor, and was the first solder in his West Point graduating class (1945) to be promoted to brigadier general, major general, and lieutenant general.

Meaning of "Fair Winds and Following Seas."

"Fair Winds and Following Seas" is a gesture of good luck to those we will miss and sailors who have served with honor and courage. The combination of phrases implies that a vessel will have good winds, and not have to pound into the waves. The phrase can be used as a toast or salutation between mariners. It is often used at a "beginning" ceremony such as a commissioning ceremony, as well as in retirement, change of command, or farewell ceremonies.

Following seas are defined by Bowditch's American Practical Navigator as "A sea in which the waves move in the general direction of the heading" and can be dangerous if the winds and sea are too strong. But the mariners' traditional blessing implies that both are comfortably rolling in the same direction as the boat.

One Man's Welcome to Vietnam!

Second picture was after boats were turned over to the Vietnamese and I was reassigned to Advance Tactical Support Base Tra Cu on the Vam Co Dong River.

By Darrel Ashlock, GMG2 1/26/69 and left 1/24/70.

January 24, 1969 the World Airways Jet was full of Navy Mobile Riverine trained sailors who had left the day before from Vallejo Calf. via Travis Airforce Base, approached Tan Son Nhut Air base near Saigon. We had to circle the airport because they were receiving incoming motor rounds. I don't know how long we circled but we finally landed.

As we deboarded the plane in our blue wool uniforms the first thing you noticed was the overbearing heat. To quote Robin Williams charter in "Good Morning" Vietnam" it was "damn hot". I had on a jumper with zippers, so I was able to unzippers each side, but it didn't help much.

We were loaded on school buses which had the windows covered with chicken wire. I asked the driver why chicken wire was over the windows, he replied, to keep hand grenades from being thrown into the bus. We arrived at the Annapolis hotel where we were spending the night. We noticed they were repairing the front. A bomb laden motorcycle parked in front of the hotel, exploded and caused significate damage to the street side of the hotel.

We were assigned to our sleeping quarters and were able to change into fatigues, which was a little cooler. Before we got settled in, we were informed that we would be assigned watch times for security of the hotel. I was assigned the midnight to 4 am watch on the roof of the hotel manning an M-60 machine gun. The hotel was along the flight line medivac helicopters took to a Saigon hospital. A number of them flew over during my watch. I heard gunfire down the street, an Army jeep with a M-60 on the back flew by, responding to the threat. We could hear a fire fight in the direction the jeep went. A little later the jeep came back by with what I assumed was a dead Vietnamese laying in the back-Welcome to Vietnam.

In the morning, we boarded a bus for a ride through Saigon and the country side to arrive in Dong Tam. I was assigned sleeping quarters, until they give me an assignment, in a hooch directly across from the helo pad that was blown up a week or so later. As I explored Dong Tam, I found the EM Club.

I ran into two guys from the boat crew I had trained with, I had been put on a medical hold and followed them a couple of months later. They were waiting for their orders back to the world because they each had three purple hearts. The boat, T-151-5 had been sunk by a command detonated mine, it was thought the mine may have been a duded 750 bomb. Two of my old crew members and a Vietnamese Marine were killed. I was fortunate to have been put on the medical hold. I also ran into guy I graduated from high school with, his tour was up and was waiting for his orders to go home.

We had a bunker just outside the door to my hooch. That night as a couple of mortars were lobed into the camp, a siren went off, and we headed into the bunkers.
